UMALUSI ACCREDITATION



Definition: Accreditation is a legal requirement for independent schools according to GENFETQA

WHAT IS NEW?

Act No. 58 of 2001. It is an outcome of a quality assurance process of evaluating an independent school to determine whether it has capacity to offer a qualification or programme leading to a qualification registered on the General and Further Education and Training Qualification Sub Framework. Accreditation with UMALUSI attests to the capacity and quality of the offering in an independent school in respect of the independent school's implementation of the curriculum in support of the school exit qualification at the required standard. WHO MAY APPLY?

UMALUSI only accredits Independent Schools offering the National Curriculum Statement in

- Grades 1 12 through CAPS leading to the National Senior Certificate (NSC)/Matric. 2. The school must first be registered with the relevant Provisional Education Department
- accredited with UMALUSI. 3. UMALUSI accredits Independent Schools which fall within its quality assurance scope, which means the school must offer qualifications on

WHAT DOES THIS MEAN FOR INDEPENDENT SCHOOLS USING ALTERNATIVE CURRICULA

LIKE A.C.E.? With regards to schools offering an alternative

curriculum, i.e., Accelerated Christian Education (A.C.E.) curriculum, note that UMALUSI accredits

and certified by UMALUSI.

schools follow the CAPS curriculum to prepare their learners to write the National Senior Certificate (NSC) or Matric examination. Therefore, AEE Schools not offering the CAPS Curriculum and preparing learners for a Matric (NSC) Examination do not need to apply for accreditation with **UMALUSI.** NB: AEE, together with NAISA, is still in talks with UMALUSI and DBE regarding the accreditation of

Alternative Curricula. Until the matter is resolved, the status quo remains. All Regulations for the registration of independent school in all 9 provinces state that the school should apply for accreditation

- after being registered with the PED. That is the standard policy position of the Department of Basic Education. However, schools offering alternative or foreign curricula cannot be accredited by UMALUSI because UMALUSI's position is that it does not accredit schools offering a foreign or alternative
- curriculum leading to a foreign qualification. However, legislation allows such schools to operate in South Africa as long they have been registered by the Provincial Education Department as in the case of the A.C.E., Waldorf and Montessori schools. UMALUSI is still in the process of finding a way

to get such schools accredited by the Council

You will need to submit a completed application form with all the supporting documents as specified in the Provincial Regulations/Measures for the Registration and Subsidy of Independent schools for the province where your school is located to the Head of Department (HOD) through the District Office where your school operates from.

The HoD must respond to your application within 90


WHY MUST YOUR SCHOOL IMPLEMENT A SCHOOL IMPROVEMENT PROGRAMME?
